LEGISLATIVE SCORECARD 2021-2022

OVERVIEW: This comprehensive scorecard aims to provide a high-level snapshot of the political landscape for children, youth, and families in Washington. Voting averages are based on floor votes (including concurrence) of priority bills we tracked in the 2021 and 2022 legislative sessions across our six interconnected main policy areas. All individual legislator votes, as well as select committee votes of CCF-endorsed legislators, are maintained internally by CCF staff.
